The **Events Director** is the Board Contact for the Event Planning Committee, which meets on the first Friday of most months, and is the primary liaison with the Recreation Department for room arrangements at the monthly meetings. This position is the most time-consuming, but the Director does not have to run events because the committee has 12 hard working members who handle these events in a professional manner.
